## Rental Terms & Conditions

Rent Your Instrument: Until you own it, or until you return it. It's up to you.

Return Any Time: No long term commitment.

Instrument Exchange: Transfer your payments to another instrument if your child changes instruments. Must have Director's approval. (\$15.00 switch fee)

Refunds: There will be no refunds on any rental payments. The instrument may be returned at any time; however, monies covering any unused portion of the rental period will be forfeited.

## Repair & Replacement Coverage

The Repair & Replacement Coverage is only offered when this Agreement is initiated. It cannot be added later.

The Repair & Replacement Coverage is not effective on delinquent accounts (10 days past due).

If your instrument is destroyed by fire or stolen through forced entry during the term of your rental, it will be replaced with like-condition merchandise as long as your rental payments stay current at all times previous to the loss and you must provide us with a notarized police report to substantiate the event of fire or forced entry within 7 working days of the incident. Theft by forced entry does not include mysterious disappearance from school band lockers or by any circumstances in which breaking and entering is not a factor.
